INTERRELATION WITH THE INTERNATIONAL TREATY ON PLANT GENETIC RESOURCES FOR FOOD AND AGRICULTURE (ITPGRFA)

1. The purpose of this document is to report on developments concerning possible areas of interrelations among the international instruments of the International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA), the World Intellectual Property Organization (WIPO) and UPOV.

BACKGROUND

2. The full background to this matter is presented in documents CC/88/10 "Interrelation with the International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA)" and CC/88/10 Add. "Addendum - Interrelation with the International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA)".

3. At its eighty-eighth session, held in Geneva on October 15, 2014, the Consultative Committee considered documents CC/88/10 and CC/88/10 Add.. It noted the communication from the Office of the Secretary of the ITPGRFA, summarizing the latest situation in relation to the invitation from the ITPGRFA to UPOV and WIPO to jointly identify possible areas of interrelations among the respective international instruments of UPOV, WIPO and the ITPGRFA, as reported in document CC/88/10 Add. (see document CC/88/16 "Report on the Conclusions", paragraphs 67 and 68).

DEVELOPMENTS

On February 17, 2015, the Office of the Union received a letter of invitation from the 4. Mr. Shakeel Bhatti, Secretary, ITPGRFA, to attend the second meeting of the Ad Hoc Technical Committee on Sustainable Use of PGRFA (ACSU), to be held in Rome on March 2 and 3, 2015, a copy of which is attached as the Annex to this document (in English only). The letter explains that the ACSU will be asked to provide advice to the Secretary of the ITPGRFA "on the identification of interrelations between the International Treaty and the relevant international instruments of UPOV and WIPO". The letter also explains that document IT/ACSU-2/15/Inf.5, which has been produced for the second meeting of ACSU, contains a compilation of all submissions that the ITPGRFA had received on that matter by early February 2015. That document be accessed at http://www.planttreaty.org/content/farmers-rights-submissions. can Document IT/ACSU2/15/4, to be produced by the Secretariat of the ITPGRFA for the relevant agenda item at the second meeting of ACSU was not available at the time of publishing this document.

5. The Office of the Union plans to attend the second meeting of ACSU and to make an oral report at the eighty-ninth session of the Consultative Committee.

6. The Consultative Committee is invited to note the developments concerning possible areas of interrelations among the international instruments of the ITPGRFA, WIPO and UPOV, and that an oral report will be made to the Consultative Committee, at its eighty-ninth session, on the second meeting of the ACSU.

Dear Dr Gurry,

I am pleased to invite you or a person whom you designate, to attend the second meeting of the Ad Hoc Technical Committee on Sustainable Use of PGRFA, which will be held in FAO - Rome, Italy, on 2-3 March 2015, in the Malaysia Room (B227).

At its 5th Session, held in Muscat from 24 to 28 September 2013, the Governing Body of the International Treaty on Plant Genetic Resources for Food and Agriculture adopted Resolution 7/2013 on the "Implementation of Article 6, Sustainable Use of Plant Genetic Resources". The Resolution endorsed the Programme of Work (PoW) on Sustainable Use of Plant Genetic Resources for Food and Agriculture (2014-2017) which included the decision to reconvene the Ad Hoc Technical Committee on Sustainable Use of PGRFA.

The first meeting of the Committee was held in Rome from 8 to 9 November 2012. During the meeting important items were discussed including:

- the draft Vision, Mission and Goals of the Work Programme for the implementation of the Sustainable Use of Plant Genetic Resources for Food and Agriculture, in accordance with Article 6 of the Treaty;
- the development of a Toolbox on the Sustainable Use of Plant Genetic Resources for Food and Agriculture
- views, experiences and best practices regarding the implementation of Farmers' Rights.

As you are certainly aware, the ACSU will be asked to provide advice to the Secretary on the implementation of Paragraph 3 of Resolution 8/2013 on the identification of interrelations between the International Treaty and the relevant international instruments of UPOV and WIPO. I have compiled all submissions, which I received until early February, in document IT/ACSU-2/15/Inf.5 and they can be accessed at http://www.planttreaty.org/content/farmers-rightssubmissions. The relevant agenda item is presented in document IT/ACSU-2/15/4.
