1. Editorial

3. Multinational seed industry pitches for further harmonization in UPOV

The multinational seed industry is pressing for more international harmonization of the plant breeders' rights protection system that will intensify corporate control. The International Seed Federation (ISF), the International Community of Breeders of Asexually Reproduced Ornamental and Fruit Plants (CIOPORA) and CropLife International (CLI) argued for this at the 88th session of the Consultative Committee (CC) of UPOV, calling for an international filing system, an UPOV quality assurance program and a central examination system for variety denominations. 4. Restricted UPOV documents published by APBREBES

Unlike most intergovernmental organisations that allow access to its meeting documents and proceedings, UPOV restricts access to meeting documents of the Consultative Council, to its member states. Thus with the aim to enhance transparency in UPOV matters, APBREBES has from time to time been making requests under various Freedom of Information Acts. The latest request has facilitated access to restricted UPOV documents concerning the 88th session of the Consultative Council meeting that was held on 15th October 2014.
