EXECUTIVE SUMMARY

1. The purpose of this document is to present a proposal to disburse the balance of the Special Project Fund in 2018.

- 2. The Consultative Committee will be invited to:
 - (a) note the activities that have been supported by the Special Project Fund;

(b) agree that all the remaining balance of the Special Project Fund (13,957 Swiss francs) be used in 2018 for activities in the context of the UPOV training and assistance strategy presented in document CC/89/4 "Special Project Fund", taking into account:

(i) the priorities set out in paragraph 4 of this document; and

(ii) the clarification of expenditure on agency staff involved in the administration of activities in the context of the UPOV training and assistance strategy in the Special Project Fund, as set out in paragraph 5 of this document.

BACKGROUND

3. In 2015, 183,824 Swiss francs, representing the amount of the reserve fund exceeding 15 per cent of the total income for the 2012-2013 Biennium, were transferred to a Special Project Fund for specific projects. Of this amount, 114,151 Swiss francs were expensed in 2015, leaving a balance of 69,673 Swiss francs as at December 31, 2015.

4. The Consultative Committee, at its ninetieth session held in Geneva on October 28 and 29, 2015, considered document CC/90/3 "Special Project Fund". The Consultative Committee noted the plans for use of the Special Project Fund in 2015 and agreed that the balance of the SPF at the end of 2015 be used in 2016 for activities in the context of the UPOV training and assistance strategy (see the Annex of document CC/90/7 "UPOV training and assistance strategy"), according to the following purposes and in the order of priority, as considered appropriate in relation to the availability of funding from other sources:

- Standard training activities organized or co-organized by UPOV
 - Contributing data to the PLUTO database;
 - Train the trainer courses;
 - Training for tutors in UPOV distance learning programs;
- Training and assistance resources;
- Training activities developed in conjunction with UPOV;
- In situ activities organized by UPOV.

5. The Consultative Committee, at its ninety-second session, held in Geneva on October 27, 2016, approved the inclusion of expenditure on agency staff involved in the administration of activities in the context of the UPOV training and assistance strategy in the Special Project Fund expenditure (see document CC/92/21 "Report", paragraph 31).
