EXECUTIVE SUMMARY

1. The Consultative Committee is invited to note that a draft Strategic Business Plan 2023-2027 will be developed for consideration by the Consultative Committee at its ninety-ninth session, to be held on October 27, 2022, and to agree that the draft Strategic Business Plan 2023-2027, as approved by the Consultative Committee, be proposed for adoption by the Council at its fifty-sixth session, to be held on October 28, 2022.

BACKGROUND

- 2. The Consultative Committee considered document CC/97/3 "Strategic Business Plan" by correspondence in 2020 (see document CC/97/15 "Outcome of the Consideration of Documents by Correspondence", paragraphs 39 to 42).
- 3. The Consultative Committee approved the draft Strategic Business Plan 2021-2025, as presented in Annex II to document CC/97/3 and requested that the Strategic Business Plan be updated on a biennial basis in order to set the direction for the subsequent two biennia and to coincide with the preparation of the draft program and budget for the subsequent biennium.
- 4. At its ninety-seventh session, held by electronic means on October 29, 2020, in response to a proposal from the Delegation of the European Union to provide a general context in relation to political and strategic developments and other trends and issues, the Vice Secretary-General proposed to introduce such a contextual background in future versions of the Strategic Business Plan, similar to the information that had been provided in Appendix I to the Annex to document CC/94/3.
- 5. The Draft Program and Budget for the 2022-2023 Biennium (document C/55/4), I. INTRODUCTION, Direction for the 2022-2023 Biennium, Introduction, explains that the Draft Program and Budget for the 2022-2023 Biennium was prepared in the context of the Strategic Business Plan 2021-2025.

- 6. In accordance with the above, a draft Strategic Business Plan 2023-2027 will be developed for consideration by the Consultative Committee at its ninety-ninth session, to be held on October 27, 2022. The draft Strategic Business Plan 2023-2027 will include a contextual background, similar to the information provided in Appendix I to the Annex to document CC/94/3.
- 7. It is proposed that the draft Strategic Business Plan 2023-2027, as approved by the Consultative Committee, be proposed for adoption by the Council at its fifty-sixth session, to be held on October 28, 2022.
